ASSESSMENT

The regulatory landscape and the best practices on sustainable finance are differently applied, depending on specific corporate sectors, contexts and perspectives.

This Seminar Series aims at introducing both the main principles and the best practices of sustainable finance. To this end, we will debate on practical case studies that consider different sectors, context and perspectives, such as corporations, financial institutions, equity and debt investors, borrowers, lenders and rating agencies. In so doing, the Seminar Series is both easily accessible and fruitful for the students of any MSc.

The Series is organized in the following 6 Seminars of about one hour and a half each. Different guest speakers will share their experience and discuss specific case studies. The coordinator supervises the design and the discussion of each case study, to guarantee the adoption of a homogenous and consistent framework.

5 November 2024

The Rise of ESG Investing: Key Approaches and the Greenium Effect

Cristiano Zazzara Adjunct Professor of Finance, Advisory Board Member of the Volatility & Risk Institute and the Climate Finance Initiative – NYU Stern School of Business

This seminar provides an overview of ESG investing, covering its rise to mainstream popularity and key strategies like screening, best-in-class selection, and sustainability-themed investing. It discusses the UN's role, how ESG factors are integrated into both stock and bond investments, and the increasing use of ESG ETFs. The seminar also examines green bonds and the "greenium" effect—where green bonds may be priced higher due to investors accepting lower returns to support environmental projects.

Equity Investing (Public and Private): Case Studies

The integration of sustainability into debt investing represents an important milestone in capital allocation strategies, aligning financial performance with ESG goals. Incorporating ESG factors into investment analysis can create a holistic view of risk factors, enhancing risk management and creating long-term value. Challenges such as data availability, standardization of ESG metrics and the evolution of the regulatory framework will be part of the seminar and case studies will be shared.
