### Article 3 Applications

The following documents must be included in the application:

• scientific curriculum, including a list of qualifications and publications;

Employees of state organizations with an Assistant Professor contract should be placed on leave of absence without grants or welfare contributions according to section 20 of article 1 of the law 230/2005.

If the candidate covers other offices or roles, they must also attach a declaration of the type of activity carried out.

Eventual external paid roles can be carried out only through authorization by the Academic Governing Bodies of Bocconi University, according to the University Regulations in force for carrying out roles not included in the assignments and duties of Professors and of University Researchers.

### Article 4 Comparative Assessment

In order to carry out a comparative assessment of the candidates, Università Bocconi will make use of a Recruiting Committee.

The Recruiting Committee will comparatively evaluate the curriculum vitae, including a list of the candidate's academic qualifications and publications.

At the end of the assessment, the Recruiting Committee will formulate an overall judgment for each candidate formulating a ranking of merit for eligible candidates and will nominate an unequivocal list of winning candidates. The proceedings of the Recruiting Committee shall be published on the university website.

The candidates will receive a communication detailing the results of the current comparative evaluation and the winners will be invited to sign the relative Assistant Professor, fixed-term employment contract.

### Article.5 Rights and Duties of the Assistant Professor

The length of the Assistant Professor contract will be individually determined and will run from  $I^{st}$  September, 2006 or from  $I^{st}$  November, 2006 and can be renewed for a total duration of 6 years, by express wishes of the parties involved with written notice and through positive evaluation of the activity undertaken, as clarified below.

When calculating the duration of the contract, the previous length of time in the role of Assistant Professor will be taken into consideration, up to a maximum of 7 years.

The Assistant Professor can carry out a paid sabbatical year which must be agreed with the competent Institute. According to the regulations, the sabbatical year will be usable in the second contractual period. For justifiable reasons, it can also be brought forward to the first contractual period.

The following commitments are assigned to the Assistant Professor:

- Teaching Activity, in the Scientific sector in which they are placed. This includes teaching and the co-ordination of multi-class activity, and of the Courses established annually by the Faculty Council and then by the Governing Bodies of the SDA Business School, for a total number of 140 classroom hours (of which 105 for the faculty) or equal to 105 in the academic year, plus the preparation of teaching material and to perform student assistance and verify their preparation.
- Explicit Scientific Research, taking on scientific co-ordination in the area of research projects developed by the Institute of referral, also in the area of other research structures within the university, with the aim of producing scientific publications in prestigious journals or publications judged equivalent by the university. These publications should usually be not less than 3 with teaching commitments of 140 classroom hours, or 5 with teaching commitments of 105 hours, before the end of the maximum duration of the present contract, including eventual renewals of three years.

#### Evaluation for contract renewal.

At the end of the first three years, the activity carried out by the Assistant Professor will be put under review, according to the following parameters.

For teaching activity: completion of teaching obligations and evaluation of individual performance, according to the University's procedures.

For research activity: evaluation of the research projects carried out and assessment of the scientific publications produced.

Assessment with a view to starting the conferral procedure of "Tenure".

Teaching activity and scientific activity carried out by the Assistant Professor will be evaluated with a view to determining whether the AP has the pre-requisites necessary, or underway, for the commencement of the tenure procedure, through the acquisition of the National Scientific Suitability (Idoneità) for Associate professors and of the subsequent comparative evaluation on the part of the University-

Intermediate and final evaluation will be considered as the results reached by the Assistant Professor during the whole period of employment with the University in that role.

### Article 6 Definition of Relationship

Winners of the present comparative evaluation will be assured gross all-inclusive payments, apportioned as follows:

- salary, paid in 13 months postdated, of equal amounts, to be paid before the 27th (twenty-seventh) day of each month, whilst the thirteenth month will be paid before the 15 (fifteenth) of the month of December of each year;

- retirement allowance (TFR): equal to 1/13.5 (a thirteenth and a half) of the gross annual salary paid, set aside annually, to be paid before the end of the following month after the end of the contract.

The Assistant Professor will be enrolled in an obligatory pension plan INPDAP (ex-CPDEL).

Lastly, the Assistant Professor will be attributed a company healthcare plan, as defined by the University Administration.

The total gross salary is gross of fiscal deductions, contributions and of every other applicable tax on the basis of the Italian law.

### Article 7 Treatment of Personal Data (Data Protection)
