According to the regulations of the competition, the Committee has concluded that the maximum scores to be allocated to admitted candidates are as follows:

- 40 points out of of 100 for the evaluation of the CV, qualifications and publications
- 60 points out of 100 for the evaluation of the interview.

Only those candidates who achieve a score of at least 21 points for the evaluation of the CV, qualifications and publications will be invited to interview.

The total minimum score to be included in the ranking list is 60.
